THIS COURT ORDERS that:

- 1. the contingency fee agreement entered into with the representative plaintiff, Darren Ewert is approved, pursuant to s. 38(1) of the Class Proceedings Act, R.S.B.C. 1996,0.50;
- 2. that an interim legal fee of \$2,412,800.00, plus applicable taxes is awarded to Class Counsel with respect to the Settlement Agreement entered into between the Plaintiffs and Yazaki Corporation and Yazaki North America, Inc. ("Yazaki"), dated October 18, 2015 (the "Yazaki Settlement Agreement");
- 3. that the Class Counsel legal fees and applicable taxes be paid from the settlement funds, payable pursuant to the terms of the Yazaki Settlement Agreement;
- 4. that this Order is contingent upon a parallel order being made by the Superior Court of Ontario, and the terms of this Order shall not be effective unless and until such an order is made by the Superior Court of Ontario; and
